The American Council on Germany is an independent, nonpartisan nonprofit organization that was founded in 1952 to strengthen German-American relations. Today, the ACG works across generations to provide a deeper, more nuanced understanding about Germany, Europe, and the importance of the transatlantic partnership. Through a range of programs and activities, the ACG addresses the most pressing economic, political, and social challenges of the day to ensure better mutual understanding.

The ACG's programs and activities are aimed at reaching a broad range of individuals to strengthen German-American relations and deepen the U.S.-European partnership. This is achieved through a combination of events and outreach designed to reach different audiences on both sides of the Atlantic to ensure they are better informed about transatlantic issues.

The Council's established initiatives include:

- A focus on the "successor generation" including the ACG's annual American-German Young Leaders Conference for rising stars from Germany and the United States as well as other activities that convene young professionals from Germany, the United States, and other countries to discuss common contemporary challenges;
- Policy discussions with experts on complex transatlantic and overarching global issues in New York City, Washington, DC, and at the ACG's Eric M. Warburg Chapters across the United States;
- Fellowships for the next generation of German and American academics, journalists, and other professionals;
- Policy conferences that engage and convene policymakers, multipliers, and leaders from government, business, academia, the military, and media on both sides of the Atlantic;
- Outreach through traditional and new media to keep ACG members and friends informed about the myriad issues affecting the German-American relationship and transatlantic affairs; and
- Experiential opportunities through fact-finding missions that give practitioners from different fields the opportunity to engage their counterparts in a deep and meaningful exchange about common challenges.

### A Message from the Chairman and the President

In November 2016, after much discussion, debate, and research, the Oxford Dictionaries announced their word of the year: *Post-truth*, an adjective defined as "relating to or denoting circumstances in which objective facts are less influential in shaping public opinion than appeals to emotion and personal belief." Less than a month later, *postfaktisch* topped the list of words of the year put forward by the Gesellschaft für deutsche Sprache.

In fact, however, the word "disruption" might better describe developments in 2016 on both sides of the Atlantic. The first big disruption of 2016 came on June 23 when British voters went to the polls to cast their vote in the historic referendum on whether the United Kingdom should remain in the European Union. It was the biggest decision faced by Britons in a generation, and the vote in favor of Brexit came as a major surprise. It toppled David Cameron's government and brought in Theresa May to manage the process of leaving the European Union. For Germany and the rest of the Continent, as well as the United States, this decision has significant implications – which are just beginning to unfold.

In the United States, after months of intense campaigning, the November 8 election of Donald J. Trump as President came as a disruption that dwarfed the Brexit vote. In Berlin and across Germany, the sense of shock the morning after the election was palpable.

Against this backdrop, developments such as Russia's acts of aggression, the rise of ISIS, and Europe's migrant crisis have threatened the stability of Europe and rattled the institutions of the European Union. It is not surprising that many Europeans believe that Europe is under threat from within and from without, and that there is a pervasive sense of anxiety.

As we see the continued ramifications and reverberations of disruption continue well into 2017, a strong transatlantic partnership is more vital than ever in order to address common overarching challenges and to guarantee peace and stability in the West.

Particularly in light of Europe's *Superwahljahr* in 2017 – with national elections in the Netherlands, France, Norway, and Germany (and possibly Italy) – there are concerns that our democratic norms will be damaged by rising populism, political polarization, and an environment where facts are open to interpretation.

In an ever-changing environment, the American Council on Germany remains committed to strengthening transatlantic ties, building mutual understanding, and helping Americans deepen their knowledge about Germany, its role within Europe and on the world stage, and broader developments within Europe.

We cannot take the transatlantic partnership for granted or rely on history and common values alone to keep us together. We must continue to work on – and nurture – the relationship. In an age of disruption, we share responsibility for meeting common challenges. Remaining true to the vision of our founders in 1952, the ACG offers a range of programs and activities designed to underscore the importance of the transatlantic partnership.

Over the course of 2016, the ACG held dozens of events in New York and a record number of events at its 21 Eric M. Warburg Chapters across the country. Many of the discussion topics focused on the key economic, political, and social issues shaping the transatlantic agenda. We continued to invest in the next generation of transatlanticists through our prestigious American-German Young Leaders Conference, which brought together some 50 rising stars. We conducted a thorough review of our fellowship programs and relaunched the McCloy Fellowship program with a focus on global trends and initiated Leadership Missions with a focus on agriculture and urban affairs. The ACG partnered with Atlantik-Brücke to hold a fourth annual joint conference, which focused on developing a new narrative for the transatlantic partnership. At our McCloy Awards Dinner, we honored Deutsche Bank's Paul Achleitner and long-serving ACG Vice Chairman Richard M. Hunt. We also continued to keep our members informed about transatlantic and global issues, through our weekly news digest and regular conference calls and podcasts with experts and officials.

In these uncertain times, when disruptive forces can shape opinion, the future of the transatlantic partnership will depend in large measure on the commitment of organizations like the ACG to work tirelessly to nurture and strengthen this relationship. At the ACG, we are dedicated to maintaining vibrant German-American ties. Building on our 65 years of transatlantic engagement, we hope we can count on your active involvement as we continue to buttress this indispensable partnership.

### **Policy Conferences**

"Toward a New Transatlantic Narrative: The German-American Partnership in Turbulent Times" May 23-24, 2016 • Washington, DC

The American Council on Germany and Atlantik-Brücke hosted the fourth annual German-American Conference, titled "Toward a New Transatlantic Narrative: The German-American Partnership in Turbulent Times," on May 23 and 24, 2016, in Washington, DC. The conference convened nearly 200 American and German opinion leaders and decision-makers from government, business, media, and academia for lively discussions concerning the most pressing issues on the transatlantic agenda.

Among the highlights of the conference were addresses by Dr. Vali Nasr, Dean of Johns Hopkins School of Advanced International Studies (SAIS), who talked about changes in the international order and today's foreign policy challenges; Ambassador Michael Punke, Deputy U.S. Trade Representative and U.S. Ambassador and Permanent Representative to the World Trade Organization in Geneva, who discussed the future of transatlantic trade; and German Ambassador to the United States Peter Wittig, who discussed the German-American relationship as the cornerstone of the transatlantic partnership.

The conference panels covered a wide range of topics, from transatlantic trade and Industry 4.0 to relations with Russia and from security and cyber-security policy to the migration crisis. Notable panelists included **Dr. Thomas Bagger**, Director of Policy Planning at the German Federal Foreign Office; Katja Gloger, Editor-

### **Transatlantic Entrepreneur Partnership Conference** and "The Global Digital Economy: Doing Business in the 21st Century"

October 10-13, 2016 • New York City

The sixth annual Transatlantic Entrepreneur Partnership (TEP) Conference, organized by New York International, Berlin Partner, and the American Council on Germany, took place from October 10 to 12, 2016, in New York City. The conference provided a platform for entrepreneurs from both sides of the Atlantic to engage in dialogue

about the most recent developments in the digital world and to meet with angel investors. More than 200 people took part in the three-day conference, which included sessions at various locations in Manhattan and Brooklyn focused on issues such as managing data; developing talent; regulatory frameworks; business development; media in the digital age; smart cities, urban technology, and transportation; and advanced manufacturing.

On October 13, the ACG and the German Consulate in New York hosted a special forum to explore the nexus of policy, innovation, entrepreneurship, and the global economy. The forum covered topics including public policy, business, trade, and education. Speakers included **Daniel Andrich**, President and CEO of the Representative of German Industry and Trade (RGIT) in Washington, DC; Danil Kerimi, Head of IT and Electronics Industries at the World Economic Forum; Ross LaJeunesse, Global Head of International Relations at Google; Dr. Arun Sundararajan, Professor of Information, Operations, and Management Sciences at the Leonard N. Stern School of Business of New York University; and Robert Tanner, Director for Digital Trade for the U.S. Trade Representative. This event was held with support from the Heinrich Böll Foundation.



### **Eric M. Warburg Chapters**

The American Council on Germany's Eric M. Warburg Chapters were created in 1992 to promote transatlantic dialogue across the United States. Named after ACG founder and longtime Treasurer Eric M. Warburg, this unique network of 21 Chapters provides ACG members and local audiences with a dynamic forum to discuss economic, political, and social issues that are important to German-American and wider transatlantic relations.

The Warburg Chapters organized more than 175 events across the country in 2016 - the largest number yet. These events focused on topics including the future of the EU and the euro area, Brexit, the refugee crisis, European and U.S. energy policies, the implications of the 2016 U.S. election, challenges in the Middle East, and other transatlantic issues. Nearly 60 policy experts, officials, business leaders, and authors visited the Warburg Chapters to address a wide range of relevant themes, engaging the American public in lively discussions about critical issues on the transatlantic agenda.

Several senior German officials addressed the challenges facing the transatlantic relationship, including German Ambassador to the United States Peter Wittig, who spoke in Dallas about U.S.-German relations. Jürgen Hardt, member of the German Bundestag and Foreign Affairs Spokesperson for the CDU/CSU Parliamentary Group, spoke in Seattle about challenges for Europe and the Middle East. Christian Schmidt, Federal Minister of Food and Agriculture, discussed whether Europe and the United States are drifting apart at the Pittsburgh Chapter.

Other speakers highlighted additional aspects concerning the future of the transatlantic relationship at many Chapter events. In February, Dr. Thorsten Wetzling, Project Leader at Stiftung Neue Verantwortung, discussed the future of transatlantic digital dialogue in Boston, Charlotte, Madison, and San Francisco. In April, Dr. Marco Overhaus, Research Associate at the German Institute for International and Security Affairs (SWP), spoke about U.S.-German foreign policy priorities in the coming years in Boston, Dallas, San Francisco, and Greater Washington. Late in the summer, Colonel Horst Busch, a career officer in the German Army, examined the role of Germany in NATO at the Indianapolis Chapter. In the fall, Boris Ruge, Minister and Deputy Chief of Mission at the German Embassy in Washington, DC, visited the Charlotte Chapter to discuss U.S.-German efforts for peace and security as well as the state of the EU. Other speakers included Hans Kundnani, Senior Transatlantic Fellow with the German Marshall Fund of the United States' Europe Program; Ronald J. Granieri (2000 Young Leader), Director of Research at the Lauder Institute for International Management at the University of Pennsylvania and Senior Fellow and Director of the Center for the Study of America and the West at the Foreign Policy Research Institute; Dr. Stefan Heumann, member of the Management Board of Stiftung Neue Verantwortung; and Fabian Wendenburg, Deputy Head of the Department for External Economic Policy at the Federation of German Industries (BDI).

The euro area, the rise of populism, and other EU issues were also covered extensively in 2016 by several speakers. Dr. Johannes **Beermann**, a member of the Executive Board of the Deutsche Bundesbank, spoke with an audience in San Francisco in March regarding the strength of the monetary union. In June, Dr. Sergey Lagodinsky, Head of the EU/North America Department at the Heinrich Böll Foundation, visited Atlanta, Dallas, Phoenix, and San Francisco to discuss the rise of populism in Germany and Europe as a whole. In the fall, Dr. Céline-Agathe Caro, Senior Policy Analyst at the Washington office of the Konrad-Adenauer-Stiftung, addressed the strain on European unity after Brexit and amid the rise of populism in Europe in Atlanta, Charlotte, Minneapolis/St. Paul, and San Diego. Several other eminent speakers addressed related issues, including Dr. Andreas Dombret, member of the Executive Board of the Deutsche Bundesbank; Dr. David Sirakov, Director of the Atlantic Academy Rhineland-Palatinate; and Jan Techau (Young Leaders Study Group on the Future of Europe), Director of the American Academy in Berlin's Richard C. Holbrooke Forum for the Study of Diplomacy and Governance.

The migrant and refugee crisis in Europe was once again a dominant issue in the media and on political agendas in 2016. Early in the year, Astrid Ziebarth, Migration Fellow with the Europe Program at the German Marshall Fund, discussed the challenges in Germany posed by the migrant crisis in Charlotte, Cleveland, Indianapolis, and San Francisco. In October, Herbert Quelle, Consul General of Germany in Chicago, spoke with the Indianapolis Chapter about the impact of the refugee crisis on the EU. Later in the fall, Dr. Bruce Leimsidor, an immigration and asylum expert, discussed human rights issues related to the refugee crisis and possible international solutions in Boston, Charlotte, and Greater Washington, DC. In December, Dr. Naika Foroutan, Professor of Integration Research and Social Policy in the Department of Social Sciences at Humboldt University in Berlin, addressed the challenges for democracy in Germany posed by the migration crisis in Boston, Minneapolis/St. Paul, Phoenix, and San Francisco. Other speakers who discussed this topic included **Thorsten** Benner, Director of the Global Public Policy Institute (GPPi); Frances **G. Burwell**, Vice President of European Union and Special Initiatives at the Atlantic Council; Professor Dr. Michael Göring, CEO and Chairman of the Board of the ZEIT-Stiftung Ebelin und Gerd Bucerius; and Hans Jörg Neumann, Consul General of Germany in Los Angeles.

Energy policy and climate change were also key topics in 2016. In the spring, Tiglet Aslan, Managing Director and Advisor at Deekeling Arndt Advisors in Communications GmbH, met with audiences in Denver, Phoenix, San Francisco, and Seattle to discuss energy policy in Germany. Dr. Daniel Klingenfeld, Head of the Director's Staff at the Potsdam Institute for Climate Impact Research (PIK), went on an extensive tour of the Chapters, including Atlanta, Boston, Charlotte, Philadelphia, Phoenix, Seattle, and Greater Washington, to address global climate-protection efforts after the Paris Climate Summit. In July, Eckart Woertz, Senior Research Fellow at CIDOB, the Barcelona Centre for International Affairs, discussed the relationship between the U.S. shale oil revolution, the Transatlantic Trade and Investment Partnership (TTIP), and European energy policy. Later in the year, **Sven Egenter**, Executive Director and Editor in Chief of Clean Energy Wire (CLEW) and klimafakten.de, analyzed ambitions and challenges for Germany's energy-transition (Energiewende) policy in the upcoming election cycle. Other speakers addressing energy and climate policy included **Dr. Rüdiger Graf**, Associate Professor of History at Webster University, and **Dr. Susanne Dröge**, a Senior Fellow in the Global Issues Division at the German Institute for International and Security Affairs (SWP) in Berlin.

Other speakers covered additional topics pertaining to Germany and the U.S. specifically. Early in the year, Dr. Joerg Forbrig, Transatlantic Fellow for Central and Eastern Europe and Director of the Fund for Belarus Democracy at the German Marshall Fund of the United States in Berlin, spoke in Boston, Charlotte, Minneapolis/St. Paul, and Nashville about Germany's historical relationship with Russia. **Dr. Christoph von Marschall** (1999 Kellen Fellow), Chief Diplomatic Correspondent at *Der Tagesspiegel*, addressed the effectiveness of Angela Merkel in dealing with the refugee crisis and the rise of populism in Atlanta, Cleveland, Minneapolis/St. Paul, Nashville, and San Francisco. Dr. Kenneth F. Ledford, Chair of the Department of History at Case Western Reserve University, and Dr. Timo Lochocki, a Transatlantic Fellow with the Europe Program at the German Marshall Fund, spoke about related topics at many of the Chapters as well. In May, Howard Dean, former Vermont Governor, and

Other speakers at the Chapters included Cornelius Adebahr, Associate in the European Program at the Carnegie Endowment for International Peace; Daniel Andrich, President and CEO of the Representative of German Industry and Trade (RGIT); Erik Kirschbaum, author and journalist, who discussed his book Burning Beethoven; Professor Dr. Erik Lehmann of the University of Augsburg, who spoke about his book *The Seven Secrets of Germany*; and **Andrew Nagorski**, author and journalist.

Another highlight of 2016 was the launch of the Los Angeles Warburg Chapter in April. Former U.S. Ambassador to Germany and ACG Chairman Robert M. Kimmitt gave the inaugural speech, addressing the common challenges faced by the United States and Germany, and the increasing importance of transatlantic understanding and cooperation. Since its launch, the LA Chapter has hosted and organized events for U.S. Ambassador to Germany John B. Emerson; Dr. Timo Lochocki, Transatlantic Fellow with the Europe Program at the German Marshall Fund; and Dr. David Sirakov, Director of the Atlantic Academy Rhineland-Palatinate.

The number of programs and diverse array of speakers at the Chapters in 2016 reflects the tremendous interest of people across the country in issues relating to the transatlantic relationship. As Germany and the United States remain close partners at the global level, the ACG is more committed than ever to promoting this dialogue through its network of Chapters.

# Programs for the Successor Generation XXXVIII American-German Young Leaders Conference

Each year the American Council on Germany's American-German Young Leaders Conference brings together up to 50 rising stars from government, business, journalism, academia, the military, and the nonprofit sector for a week of intensive dialogue about the pressing economic, political, and social issues affecting both countries. The conference expands participants' understanding of the current international agenda while deepening mutual understanding among the next generation of thought leaders and decision-makers from the United States and Germany.

The XXXVIII American-German Young Leaders Conference, which took place from July 24 to 28, 2016, in Berlin, focused on "Making the Alliance Great Again? The West at a Crossroads." The group included up-and-coming professionals at Fortune 500 companies, the founder of an energy company, a law professor, an Army strategist, an economist, journalists, and senior staff in the German Bundestag, Federal Ministry of Finance, Ministry of the Interior, Foreign Office, and the European Commission, among others.

The Young Leaders met with high-level officials including **Peter Altmaier**, Head of the Federal Chancellery and Federal Minister for Special Tasks; **Rainer Baake**, State Secretary at the Federal Ministry for Economic Affairs and Energy; U.S. Ambassador to Germany **John B. Emerson**; German Bundestag member **Christian Flisek** (SPD); **Dr. Emily Haber**, State Secretary at the Federal Ministry of the Interior; **Dr. Georg Schütte**, State Secretary at the Federal Ministry of Education and Research; **Dr. Thomas Steffen**, State Secretary at the Federal Ministry of Finance; and **Lt. General Dieter Warnecke**, Director General of the Division of Strategy and Military Operations at the Federal Ministry of Defense. They also heard from **Ulrich Grillo**, President of the Federation of German Industries (BDI), and visited the German Tech Entrepreneurship Center (GTEC) to learn about start-ups and innovation in Germany from experts and practitioners.

In addition, the Young Leaders met in working groups and plenaries to consider today's litany of significant global challenges – and to formulate policy prescriptions. They tackled eight overarching sets of issues:

- "Who Are You? What Does It Mean to Be an American and German Today?";
- "Values Proposition: What Unifies and Differentiates a Transatlantic Relationship?";
- "The Rise of Populism: How Can the Center Hold?";
- "Eight Years after the Victory Column Address: Where Do We Stand?";
- "Trust & Trade: Can Innovation and Regulation Coexist in a Global Economy?";
- "Migration, Defense, and Growth: Tackling the Tough Issues";
- "Lessons Learned: Where Europe and the U.S. Are Getting It Right"; and
- "Making the Relationship Great Again: Setting a Transatlantic Agenda for 2017."

The connections forged during the group's week together in Berlin are only the beginning. Further connections will be forged over time at alumni events and otherwise.

This was an exciting and inspiring experience that without doubt will have an enduring effect on me.

The discussions we had as well as the lectures we were given have opened up new perspectives, and

I believe they have given me a deeper understanding of the challenges transatlantic relations are currently facing. What I liked most is that, despite certain differences in perspectives, both the American and the German members of the group were willing to try to develop a common outlook on our topics.



### **Fellowships**

2016 marked the 40th anniversary of the American Council on Germany's fellowship programs. Since their creation in 1976, the programs have enabled more than 1,000 young professionals, journalists, and academics to travel across the Atlantic to conduct research and exchange best practices with their transatlantic counterparts. In 2016, 10 individuals received a fellowship from the ACG.

### MCCLOY FELLOWSHIPS ON GLOBAL TRENDS

Named after the ACG's founding Chairman, John J. McCloy, these fellowships provide young professionals the unique opportunity to conduct research on key issues within transatlantic relations. In 2016, the McCloy Fellowship program was redesigned to place an emphasis on addressing tomorrow's challenges. Five outstanding individuals were awarded a McCloy Fellowship on Global Trends, which focuses on urbanization, climate change and sustainability, technological breakthroughs, and demographics and social change. Natasha Haverty, a reporter for National Public Radio, is looking at how unaccompanied-minor refugees adjust to life in Berlin. Taylor Jordan, Professional Staff Member for the Committee on Science, Space, and Technology of the U.S. House of Representatives, traveled to Germany to explore the success of climate-change policies in the United States and Germany. Mareike Meyn, Policy Advisor for the Andreas Hermes Akademie Plattform Ländliche Räume, is examining digitalization in rural areas of the United States. Jessica Wurwarg, Energy Manager for the New York City Department of Transportation, explored the policies in urban sustainability in Germany as compared with New York City. Maria Zahout, a journalist at Nürnberger Zeitung, is examining the role of women in cyber-security.

### **HUNT FELLOWSHIPS**

The Dr. Richard M. Hunt Fellowships for the Study of German Politics, Culture, and Society provide American academics the opportunity to complete in-depth research on key themes in contemporary German history. The fellowships were created in 2003 in honor of Dr. Richard M. Hunt, former President and current Vice Chairman of the ACG.

Two Hunt Fellowships were awarded in 2016. Elvira Basevich, a Ph.D. candidate at the CUNY Graduate Center, is researching the purpose of the state in 19th- and 20th-century American and German history. Dr. David Gerlach, Associate Professor of History at Saint Peter's University, is exploring the various ways the United States influenced postwar German history in relation to reparations and property rights.

### **KELLEN FELLOWSHIPS**

The Anna-Maria and Stephen M. Kellen Fellowship program gives Berlin-based German journalists the opportunity to travel to the United States to conduct research on key themes in transatlantic relations. The Kellen Fellowships began in 1997 thanks to the generous support of the Anna-Maria and Stephen Kellen Foundation.

Three Kellen Fellows were selected in 2016. **Simon Book**, a reporter with WirtschaftsWoche, researched the future of transatlantic trade. Justus von Daniels, a reporter with Correctiv GmbH, is exploring the cost of living and minimum wage in the United States. Marlene Halser, Head of Society and Media at Die Tageszeitung, is researching populism in the United States both on the far right and far left.

By learning about Germany's cutting-edge work in energy efficiency and sustainable food production, and building transatlantic relationships and dialogues surrounding these themes, I was able to gain an understanding as to how these policies and programs function in Germany, and I can see how some of these innovations may or may not work in New York City and other U.S. municipalities.

### **Leadership Missions**

### MCCLOY LEADERSHIP MISSION ON AGRICULTURE, FOOD SECURITY, AND RESOURCE SCARCITY

Building on the ACG's 30-year history of exploring agricultural issues, in the fall of 2016, the Council launched the McCloy Leadership Mission on Agriculture, Food Security, and Resource Scarcity to give practitioners the opportunity to study agricultural, farm, and food-supply conditions on the other side of the Atlantic. In October, four American agricultural professionals traveled to Germany to exchange best practices with their German counterparts.

During their 12 days abroad, the group had the opportunity to discuss farming and agricultural policy while visiting Berlin, Bonn, Münster, and Stendal. Many of the conversations focused on sustainable farming and renewable energy, as well as government regulations and trade agreements.

The 2016 delegation consisted of: **Joshua Geigle**, Family Farm and Ranch Partner from South Dakota; **Dr. Elizabeth Kohtz**, Dairy Veterinarian and Owner/Manager of QK Farms and an American Farm Bureau Grassroots Outreach Team Member from Idaho; **Benjamin LaCross**, Operations Manager for LaCross Farms and a member of the Michigan Farm Bureau Board of Directors; and **Hilary Maricle**, a member of the Boone County (Nebraska) Board of Commissioners and the Board of the American Farm Bureau Foundation for Agriculture.

This Leadership Mission was conducted in cooperation with the American Farm Bureau Federation and the Deutscher Bauernverband (German Farmers' Association).

### MCCLOY LEADERSHIP MISSION ON URBAN AFFAIRS AND SUSTAINABILITY

In September 2016, the American Council on Germany launched the McCloy Leadership Mission on Urban Affairs and Sustainability with the goal of bringing together local government officials and their transatlantic counterparts to gain a better understanding of issues faced by cities and solutions to those challenges. The goal is to give participants an up-close look at city management and government administration across the Atlantic.

Over the course of 12 days, four German urban affairs professionals traveled to Charlotte, Pittsburgh, and Washington, DC, and its surrounding areas. In each location, the participants were able to meet with policymakers and nongovernmental organizations to discuss key issues affecting cities today, including sustainability, crime, immigration, and infrastructure.

The German cohort consisted of: **Christian Campe**, Head of the Law Department and Head of the Culture Division for the City of Hameln; **Tobias David**, Personal Consultant/Assistant to the Lord Mayor of Leipzig; **Esther Keller**, Deputy Head of the Division for International Relations at the Mayor's Office in Berlin; **Silvia Kistner**, Official in Land Use Management for the City of Karlsruhe; **Matthias Krebs**, Manager of Strategic City Development in the City of Mannheim; and **Nadja Taube**, Energy Manager at the Department of Facility Management for the City of Düsseldorf.

This Leadership Mission was conducted in cooperation with the Deutscher Städtetag (Association of German Cities) and the National League of Cities.

### Partners in Promoting Transatlantic Cooperation 2016 John J. McCloy Awards Dinner

Each year the American Council on Germany presents its prestigious John J. McCloy Award to a prominent CEO of a German or an American company for his or her key roles in promoting transatlantic economic relations. The John J. McCloy Awards, first presented in 1993, are named in honor of John J. McCloy, the founding Chairman of the American Council on Germany and the first civilian U.S. High Commissioner for Germany after World War II.

On June 15, 2016, more than 300 members and friends of the ACG came together at the 24th annual John J. McCloy Awards Dinner to honor **Dr. Paul M. Achleitner**, Chairman of the Supervisory Board of Deutsche Bank, and **Dr. Richard M. Hunt**, University Marshal a.D. of Harvard University and ACG Vice Chairman. **Ambassador Robert M. Kimmitt**, ACG Chairman and Senior International Counsel at WilmerHale LLP, was the emcee of the dinner, which took place at the Grand Hyatt at Grand Central in New York City. **Brita Wagener**, Consul General of Germany in New York, read a letter from Chancellor Merkel, and **Conrad R. Tribble**, Deputy Assistant Secretary of State for Western Europe and EU Affairs, read a letter from President Obama.

ACG Board member **Dr. Henry A. Kissinger** told those gathered that Dr. Achleitner embodies the "conscience of key institutions in the German economy like John J. McCloy did of the political system of his day." Dr. Kissinger also paid tribute to Dr. Hunt for his role in building the German-American partnership since the 1950s.
